The School of Architecture, Planning and Landscape invites applications for a term certain *Sessional Instructor* to teach EVDS 697.XX – Municipal Planning Law. This course will be taught during the SAPL Winter 2020 Block Week, March 9 – 13. Some additional time in the form of office hours for students is expected. This is an elective course in the Master of Planning program within the School.

Course Description

This course will introduce participants to Alberta's municipal government planning and development law and practice. Participants will learn the processes involved in submitting and reviewing a development permit application and an application for a subdivision approval. Exploration of the Municipal Government Act and growth planning and collaboration are other themes of the course.

Requirements

The successful candidate will have completed at least a professional degree in Planning or a related discipline, have academic and/or professional experience in municipal law and have prior teaching experience at the graduate level.
